- SECTION 14 ON OUR SAFETY DATA SHEET (WHICH IS ON OUR WEBSITE UNDER THE "SDS" SECTION) DETAILS THE TRANSPORT INFORMATION
 - IT SAYS "THE PRODUCT IS TO BE SHIPPED AS LIMITED QUANTITY. THE PRODUCT IS NOT PRODUCED IN SIZES EXCEEDING THE LIMITED QUANTITY THRESHOLD OF 500 ML FOR INNER PACKAGINGS. GROSS PACKAGE WEIGHT NOT TO EXCEED 30 KG."
